

Payment of Dividends

São Paulo, September 30, 2019 – A EZ TEC Empreendimentos e Participações S.A. (“Company” or “EZTEC”) (Bovespa: EZTC3; Bloomberg EZTC3:BZ), informs its shareholders that, in the Annual Shareholders’ Meeting held on April 26, 2019, at 10 a.m., payment of dividends of the year of 2018 was approved in the amount of twenty-three million, one hundred and sixty-five thousand, nine hundred and three reais and sixteen cents (R\$ 23,165,903.16), equivalent to R\$0.140397896 per ordinary share.

The dividends will be paid to the shareholders on October 04, 2019, based on the stock position of April 26, 2019, and the total amount of shares entitled to dividends held by shareholders on such date, and as of April 29, 2019 (inclusive), the shares of the Company will be traded ex-dividends. Dividends shall be paid without any indexation or withholding income tax, in the terms set forth in article 10, of Law No. 9.249/95.

As a clarification, the shares issued after the Annual Shareholders’ Meeting at April 26, 2019, (i) due to the bonification approved in that same Annual Shareholders’ Meeting or (ii) as the result of the primary public offering distribution of common shares approved by the Board of Directors’ Meeting at September 11, 2019, are not entitled to such dividends.

The shareholders will have their credits available according to the banking address provided to Itaú Unibanco S.A., the depository institution for the Company’s shares, as of the payment date set forth above.

In the case of shareholders whose shares are held in the stock exchange market, it will be paid through their custody agents (Stock Brokers).

For those shareholders whose registration does not contain their corporate or individual taxpayer’s numbers (CNPJ/MF or CPF/MF, respectively), or the indication of their “Bank/Branch/Bank Account”, the dividends will only be credited after the third business day, counted as of the date of the registration’s update in the electronic files of Itaú Unibanco S.A., which may be carried out in any branch of the chain or in the specialized branches indicated below.
