

## Payment of Fraction Shares resulting from the emission of Bonus shares

**São Paulo, June 23<sup>rd</sup>, 2016 - EZTEC S.A. (Bovespa: EZTC3; Bloomberg EZTC3:BZ)** announces to its shareholders that the Fraction Shares, resulting from the emission of Bonus Shares approved in the Extraordinary Shareholders' Meeting held on April 29<sup>th</sup>, 2016, were grouped into whole numbers and sold and sold in the BM&FBOVESPA S.A. – *Bolsa de Valores, Mercadorias e Futuros* (Stock, Commodities and Future Exchange), during auction held in June 21<sup>st</sup>, 2016.

In this auction, **3,313** ordinary, book-entry and with no par-value shares were sold for **R\$16.05277270953** per share.

The resulting values will be made available to shareholders in **June 30<sup>th</sup>, 2016**, respecting shareholders' fraction amount, related to shareholders' position of **April 29<sup>th</sup>, 2016**. The manner these funds will be paid:

- I. For Shareholders with bank account registered in the Depository Institution: values will be paid to the registered bank accounts
- II. For Shareholders with Fraction Shares under custody in the CBLC - *Companhia Brasileira de Liquidação e Custódia* (Brazilian Liquidation and Custody Company): values will be paid to CBLC, which will then transfer the amounts to shareholders through their respective custody agents
