# Lengthening of the Debt Maturity of Borrowings and **Financing**

Recife, December 29, 2020, Ser Educacional (B3 SEER3), one of the largest private education groups in Brazil and the leader in the Northeast and North regions, pursuant to paragraph 4 of article 157 of Law 6,404/1976 and CVM Instruction 358/2002, hereby informs its shareholders and the market in general that it has concluded the lengthening of the maturity schedule of its financial debt, thus reducing average funding costs and optimizing the amortization cash flow.

The Company renegotiated financing agreements entered into with Itaú Unibanco S.A ("Itaú") and Banco Santander Brasil S.A ("Santander") to reinforce its cash position as a way to prevent financial impacts arising from the Coronavirus pandemic (Covid-19), as per the Material Fact disclosed to the market on April 30, 2020.
